## Exhibitor Rules and Regulations

1. It is understood and agreed that this is an application only until accepted in writing by Love of Labs, Indiana (LOLIN). It is also understood and agreed by undersigned exhibitor that after the acceptance and approval of this application, said application should become a contract between exhibitor and Love of Labs, Indiana (LOLIN). Here forth referred to as Love of Labs, Indiana (LOLIN). The exhibitor agrees to pay promptly all rentals when due and to abide by the terms and regulations below.
2. Subletting of contracted exhibit space is NOT permitted. Special arrangements must be made, in advance, for two or more firms occupying the same exhibit space.
3. Exhibitor must provide own set up for booth including covered tables, chairs, and canopy.
4. Love of Labs, Indiana (LOLIN), and/or Mallow Run Winery shall not be held responsible for any loss or damage that may result from robbery, theft, fire, strikes, accidents or other destructive causes Love of Labs, Indiana (LOLIN) insurance does not extend to exhibitor's property.
5. Any violation of any of the terms and conditions of these rules and regulations on the part of any exhibitor will be cause to terminate the agreement to occupy space, and such exhibitor will forfeit to Love of Labs, Indiana (LOLIN) all monies which may have been paid. In case of any violation of the terms and conditions of these rules and regulations on the part of the Exhibitor, right is hereby given to Love of Labs, Indiana, to terminate the contract to occupy space, at its option, and Love of Labs, Indiana (LOLIN) may re-enter and take possession of the space occupied by the Exhibitor, and remove all persons and goods at the Exhibitor's own risk, without liability of Love of Labs, Indiana (LOLIN) therefore.
6. Love of Labs, Indiana (LOLIN) reserves the right to deny or refuse any space application - or insist upon the removal of any exhibit which it decides is offensive or not appropriate.
7. All decisions involving exhibitors made by the Love of Labs, Indiana (LOLIN) management shall be final.
8. In the event that this space agreement is subject to any federal, state, or municipal taxes, or other tax now or hereafter enacted, the amount of such tax shall be added to the price above agreed.
9. Love of Labs, Indiana (LOLIN) will not be liable for any injury, loss or damages to the person or property of any exhibitor, or its employees, agents, guest or invitees arising from or in any way connected with the use of occupancy of exhibitor's space. The exhibitor agrees to indemnify and hold harmless Love of Labs, Indiana (LOLIN) against all claims arising out of acts or omissions of the exhibitor, its employees, agents, guests or invitees.
10. Any matters not covered by these rules are subject to the sole discretion of Love of Labs, Indiana (LOLIN).
11. At the close of the event if Exhibitor owes Love of Labs, Indiana (LOLIN) any sums arising hereunder, or if Exhibitor fails to remove an exhibit, equipment or paraphernalia at the time determined by Love of Labs, Indiana (LOLIN), Love of Labs, Indiana (LOLIN) is hereby given permission by Exhibitor to take immediate possession of Exhibitor's exhibit, equipment or paraphernalia. Same may be removed, sold at public sale or private sale with notice to Exhibitor and without relief from valuation or appraisal laws, in order to defray any sums due Love of Labs, Indiana or to pay removal costs. No dismantling or removal of booths is permitted prior to the official announced closing time on final day of show. Exhibitor acknowledges that in the event it dismantles or removes its booth(s) prior to the announced closing the Event as well as other exhibitors may be harmed. The damages suffered if such an event were to occur would be uncertain and difficult to ascertain. Exhibitor thereby agrees to pay Love of Labs, Indiana (LOLIN) liquidated damages for unauthorized dismantling or removal of its exhibit, a sum equal to the total space cost Exhibitor is obligated to pay Exhibitor acknowledges that the sum indicated as liquidated damages is not unreasonable and should not be considered a penalty.



## Exhibitor Rules and Regulations

12. Love of Labs, Indiana (LOLIN) will not be liable for the fulfillment of this agreement as to the delivery of space if non delivery is due to: fire, act of God, public enemy, war or insurrections, strikes, the authority of the law, postponement or cancellation of the event, or any other cause beyond Labapalooza management's control.

Love of Labs Indiana management will, however, in the event of not being able to deliver space for any of the foregoing reasons, reimburse Exhibitor for any amount paid, less any and all reasonable expenses incurred by Love of Labs, Indiana (LOLIN) for advertising, salaries, operating expenses, etc.

13. In the event Exhibitor defaults in the performance or observance of any of the terms and regulations contained in this agreement, or Love of Labs, Indiana (LOLIN) employs attorneys to enforce all or any part of this agreement, Exhibitor will reimburse Love of Labs, Indiana (LOLIN) for the attorney fees incurred, whether or not suit is actually filed.

14. This agreement shall be governed in accordance with the laws of the State of Indiana. Should Love of Labs, Indiana (LOLIN) commence or maintain litigation to enforce the agreement, Exhibitor agrees to submit itself to the jurisdiction of the courts of Johnson County, Indiana, for the purpose of such litigation and hereby waves any objection it might have to such litigation been commenced or maintained in the courts of Johnson County, Indiana, on the basis of lack of subject matter jurisdiction, lack of personal jurisdiction, improper venue or inconvenient forum.

15. All vendors must have their booth space set up and ready no later than 11:30 pm on day of event. There must be someone at the booth space at all times during the event and the booths may not be shut down prior to 6 pm, close of the event.

16. Exhibits with animals must have all licenses, permits and vaccinations required by the City, State or Federal government bodies with jurisdiction over the display, care and handling of such animals. All dogs and cats must be spayed or neutered. Love of Labs, Indiana (LOLIN) reserves the right to approve any animal or the display of any animal at the event. Any animal that the event or its agents deem unhealthy, not cared for, too dangerous or in any other way not satisfactory for display at the event must be immediately removed from the event by the Exhibitor upon notification. No animals may be sold on premises. Exhibitors are responsible for removal of pet waste, food and other related materials to the approved waste receptacles.
